Oriental Egg Donors are priced between USD 2,500 for Cambodian Donors and Thai Egg Donors are priced between \$5,000- \$6,000

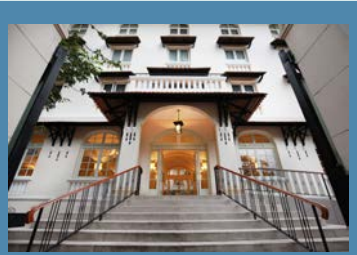
